Service Provider and Customer are collectively referred to as Parties (hereinafter: Parties) - today, under the following terms and conditions.

Parties acknowledge that the Service Provider operates Rózsakert Medical Center (hereinafter: RMC) which provides healthcare services to the clients seeking its services.

Under the framework of the outpatient clinic, the RMC facility provides outpatient and same day surgery care. The list of the services provided by the RMC at all times, the current business hours of the RMC, the paediatrics on-duty hours, the contacts of the Service Provider and the General Terms and Conditions (GTC) set forth by the Service Provider are available on the Service Provider's website (www.rmc.hu) and in a printed form at the registered office of the Service Provider, and the GTC is also placed in the patient waiting lounge. Service Provider may unilaterally amend the GTC, in which case the modification shall be published - no later than

15 days prior to the date of the modification's entry in force - on its website, and it shall make it available in a printed form in the patient waiting lounge of the RMC.

Parties agree that Customer uses the healthcare services of the Service Provider with the terms and conditions set forth herein and the GTC, and the Privacy Information while the Service Provider is obliged to provide professional healthcare services to the Customer, with the terms and conditions set forth herein and the GTC, and the Privacy Information.

Customer declares to have read and understood the provisions, data and information about the services of the RMS set forth in the GTC's current version at the date of concluding this contract, the Service Provider has informed him/her thoroughly and completely thereof, he/she has received satisfying answers to all questions asked verbally and/or in writing, completely understood the answers and based on the above, he/she accepts the provisions of the GTC as binding.

Customer declares to have been informed by the Service Provider on those provisions of the GTC upon which extra fees (availability assignment fee in case of no cancel of a reserved appointment, and compensation, and in case of a person lacking partial or full legal capacity, a direct surety undertaken by the statutory representative signing this agreement), may be charged on the Customer apart from the service fees and that Customer accepts such provisions separately and expressly by signing this agreement.

Under the penalty of exclusive liability, Customer hereby declares that the above data are true and valid, and he/she shall report any changes thereto - within 8 days after the occurrence of the change - in writing to the Service Provider.

Upon signing this agreement, Client declares to have been informed about the service fees of the RMC at the time of concluding this contract, to have understood the information provided, to completely understand the sums of fees, their methods of calculation, the methods and deadlines of payment, the obligation to provide collateral for the payment of the service fee, the options of the Service Provider's unilateral modification of the list of fees, and that he/she has received satisfying answers to all questions asked verbally and/or in writing, completely understood the answers and accepts the provisions thereof as binding.

To issues not regulated herein, provision of the Civil Code, Act CLIV of 1997 on Healthcare and other regulations shall apply.

This contract is approved by the Parties with their signatures, after mutual reading and understanding, being consistent with their mutual wills.

Upon concluding this contract, the Customer acknowledges that the Service Provider has directly called his/her attention to the fact that the currently applied GTC, an integral part hereto, is new and it is partially different from the terms and conditions applied to the relationship of the parties before. Therefore the Service Provider has specifically request the Customer to study the provision thereof before signing this contract. Customer expressly and specifically accepts the provisions of this new GTC as binding.
